The sun has been shining brightly on our mountain of late. With all the rain we have had, everything is green and beautiful! Summer begins tomorrow and outdoor activities are in full swing. How fortunate we are to be here!

We are approaching our yearly July membership meeting and I would like to update you on this past year's activities and accomplishments. Many of you are painfully aware of the issues that the warm weather brings to the mountain. There are people seeking access to the river who are not always courteous and respectful and cause distress and unsafe situations to the mountain citizenry.

There was a community meeting held at the Camp Rose Inn on this topic last July. Additionally, Al Pucci and I, along with Don King of the Del Rio Woods Park Recreation District met with our newly elected Sheriff, Steve Freitas on May 16, 2011. We discussed concerns on the mountain and how we ALL could support law enforcement in keeping our living area safe for all. You may have noticed that there has been a very strong presence of law enforcement on the mountain already. Please reference the numbers listed in this newsletter. I would encourage you to call and report anything of concern. It may take some time (depending on the seriousness of the issue) but they will respond. Please reference the numbers listed in this newsletter. Donita Proctor and I met with Supervisor Mike McGuire and his staff to discuss the need for a rate increase for CSA 41 Water District customers. Additionally, a public informational meeting was held in early May at the Healdsburg City Hall to present options and receive input. The notice for rate change increase that you have received has the option voted on by those in attendance.

There was also an informational meeting on the state of affairs with the mountain top property hosted by our Supervisor. Fitch Mountain was well represented and all were allowed time at the microphone. I am pleased to announce that Supervisor McGuire will be at our July 10th membership Meeting to update us on the state of issues affecting our living space.

A community service work weekend was held at the Villa BBQ/Picnic area on May 21-22. This neglected area was transformed by our willing band of volunteers. There is a separate piece that discusses this further.

A charitable donation of \$200.00 was made to the RUSSIAN RIVERKEEPER in support of maintaining the health and beauty of our river ecosystem. Don McEnhill, the RUSSIAN RIVERKEEPER, spoke on the river's scourge Ludwigia last year. We hope to offer another educational opportunity this year. More to follow at the meeting.

We have elections this July and I am pleased to report the infusion of new energy and volunteers to our board. Please view their bios and welcome them at our July meeting. Meeting with Sheriff Freitas

On May 16th representatives from the Fitch Mountain Association (FMA) and the Del Rio Woods Recreation and Park District (DRWRPD) met with Sheriff Freitas in his office to discuss the many concerns of the Fitch Mountain residents. Laura Rodriguez, President of FMA, Don King, President of the DRWRPD Board of Directors, yours truly, on both boards, and the Sheriff met for forty-five minutes.

The discussion centered on what we, FMA and the DRWRPD in particular and the residents of the mountain, in general, could do to support the Sheriff's office and what, if anything, the Sheriff could do to assist us in maintaining order in our community. We discussed underage drinking, illegally parked vehicles, trespassers going to the river and, in general, the rowdy behavior of the youths who come to the river and negatively impact our community, essentially beginning with the Memorial Day Weekend and lasting through the summer months.

The DRWRPD now has an ordinance prohibiting the consumption of alcohol on the beach that is enforceable by law enforcement agencies; FMA will disseminate phone numbers of relevant law enforcement agencies to its members. The Sheriff stressed that the residents of the mountain can act as his ears and eyes re. illegal behavior and emphasized the importance of the residents calling his office with reports of such behavior.

Two pictures, taken by a resident of the mountain, which showed over fifty young, and very likely, underaged drinkers on a small island about one-quarter of a mile down river from the Del Rio beach, were brought to the meeting and shared with the Sheriff. He wrote many notes on the pictures and stated that he would make the deputies who patrol the area aware of the situation. This was a good example of a local resident bringing a problem to the attention of the Sheriff.

I left the meeting with a renewed sense of confidence that we, the Sheriff, and us - DRWRPD, FMA, and the residents of the mountain - would be able to bring back a wholesome environment to the area. The events of the Memorial Day Weekend confirmed my confidence; there was a large group of young folks drinking on the above mentioned island, illegally parked cars and unruly behavior on the roads and beaches throughout the area. Many citations were given for under aged drinking, two DUI arrests were made and, to cap this off, a Sheriff's

helicopter landed on the island to deal with that situation. About two weeks later another group of young folks gathered on that island. Two deputies borrowed a canoe and paddled down to the gathering and, once again, confronted the youths and solved the problem. The Sheriff's Department has gone the extra mile to assist us in attaining a welcoming environment for those who want to enjoy a nice day on the river. Let us all assist him by acting as his ears and eyes.

NOTES: FITCH MOUNTAIN WATER SERVICE MEETING

MAY 3, 2011-HEALDSBURG CITY HALL 6:30-8:30 p.m.

FMA wishes to thank the approximately 40 members who attended the meeting in person and the quick e-mail responses with options choice sent in by those who could not attend the meeting. We are especially grateful to 4th District Supervisor Mike McGuire for his initiation of a preliminary meeting with representatives of FMA, President Laura Rodriguez and Donita Proctor, Trustee on April 1, 2011 at his office. Before this meeting we were provided with the proposed budget for 2011-2012 for distribution to our trustees. Proposal for rate increases to offset the declining reserves was discussed and a tentative date for a community meeting with consumers was set. Results of the community meeting May 3, 2011 are recapped below.

Attending presenters from the county of Sonoma: **Mike McGuire 4th District Supervisor, Donna Caldwell, budget analyst, Tom O'Kane, Deputy Director of Transportation and Public Works, Stephen B. Urbanek, P.E., Pavement Preservation Manager, Christopher Anderson, District Director office of Mike McGuire.**

Mike McGuire introduced the panel for discussion and gave a history of the preliminary meeting 4/1/2011. He explained the process of the meeting. Steve Urbanek gave an overview of the system and a report of capital improvements impacting the reserve fund.

1. Purchase of a backup generator for the McDonough Heights pump to the distribution system in case of power outages: \$17,049. The McDonough Heights area of Fitch Mountain Water District is situated above the water storage tanks that supply the other residents by means of gravity feed. Water flow is maintained to these customers by the way of electric pumps. With the sometimes frequent power outages that can occur in the area there are times these properties are left without water. **To maintain fire safety** and convenience to these customers an emergency generator is in the process of being installed.

2. Purchase of a new master flow meter (cost split 50/50 with the City of Healdsburg) Steve Urbanek (who will now take over system oversight) and Tom O'Kane gave a background on options for the future of the system with discussions about operations and maintenance being taken over by the City of Healdsburg or Russian River Utility (current contractor for operations and maintenance). <http://www.rruwater.com/countyWater.shtml>

The system is now operated under public works which does not specialize in water systems. Administrative cost of Public Works personnel and billing service is charged to the Fitch Mountain Water system. Tom O'Kane had previously stated the smaller districts within CSA#41 are moving toward becoming independent districts. (The four water systems in County Service Area 41's "Zone of Benefit" are Fitch Mountain [346 customers], Jenner [123], Salmon Creek [99], and Freestone [28].)

Benefits for City of Healdsburg operation would be economy of scale (admin cost spread over a large user base) and the advantage of lower water rates, currently \$20.00 a month less than our water service with double the water. Our current average use is \$60.00 a month and 4742 gallons a month.

Benefits for Russian River Utility: Lower admin cost, reduced audit charges required by state law for county administration. Familiarity and experience with the system. Caveat RRU is a "for profit" enterprise.

Donna Caldwell discussed the budget and water usage stats. She noted a significant increase in Utilities (Water purchase and utility charges) for the first nine months of this year. 2.9 million gallons, or 650 gallons per month per user!) in the past 9 months. The 650 gal/user math works out for a little more than a year.

Our water cost for the previous fiscal year (July-June) was ~\$88,000. As of the end of March 2011, the 3/4 point of the current FY, our water costs have already reached ~\$87,000, and the reserves are down. They were equal to last year's total charges. She answered many questions about the budget from the audience. Donna outlined the procedure for the required Proposition 218 budget hearing by the board of supervisors. 1st reading June 26, 2nd reading July 12- **Effective date Aug. 12th**, with new charges reflected in the September billing.

Mike McGuire asked for a consensus vote from the proposed options. The audience opted for Option 2. This increase is 34% over three years. See table on the next page.

otes:

1. Current ordinance in place allow for annual increases based on the Consumer Price Index (CPI). Each of the scenarios above assumes a CPI increase in each year at 1%.
2. To comply with government regulations, every other fiscal year a financial audit of the system is required. The audit costs the system approximately \$15,000.00 each year that it is required.

Follow up actions.

1. Begin exploration talks with both Russian River Utility and the City of Healdsburg. McGuire stated that if the City of Healdsburg option were chosen it would be two to three years out as a government agency requires feasibility study, discussion with the City Council etc. The option for Russian River Utility would be more expeditious. System users would vote before either option was implemented.

2. Public works will undertake a system loss report to determine why there has been a significant spike in water usage.

3. Public works will explore the “rounded” meter reading reported by the consumers at the meeting.

4. Prop.218 public hearing procedures will be implemented as described above.

5. Public works will continue working with fire services to determine responsibility for fire hydrant testing.

6. Donita Proctor was designated as “Ombudsman” for communication of member concerns/communication to public works and distribution of information from the county to consumers. Questions and concerns should be sent to donitaproctor@gmail.com

2) written protests will be accepted if hand delivered to the Clerk of the Board prior to the close of the public hearing on July 12, 2011.
